ADDITIONAL INFORMATION BRIDES

FOR FULL TRANSPARENCY, HERE ARE SOME POLICIES THAT MAY HAVE AN AFFECT ON YOUR DECISION TO BOOK WITH ME.

BOOKING: TO BOOK AND SECURE YOUR WEDDING DATE, THIS FORM/CONTRACT MUST BE FILLED OUT AND SENT BACK TO ME WITH THE **30% DEPOSIT**. WITHIN THAT TIME, I ONLY HOLD DATES FOR 7 DAYS AS A COURTESY TO ALLOW YOU TIME TO FILL THIS FORM OUT. AFTER 7 DAYS, **IF I HAVE NOT RECEIVED THE DEPOSIT AND A FILLED OUT FORM/CONTRACT, YOUR WEDDING DATE CAN BE TAKEN BY ANOTHER BRIDE.**

PAYMENT: FULL PAYMENT IS **DUE 60 DAYS BEFORE** THE BOOKED WEDDING DATE. **PAYMENT WILL BE PAID BY THE BRIDE VIA ETRANSFER BEFORE 60 DAYS OF THE STATED WEDDING DATE.** EVERY DAY THAT THAT PAYMENT IS LATE, A **\$25 LATE FEE** WILL BE CHARGED, AND AN UPDATED INVOICE WILL BE SENT. IF FULL PAYMENT IS NOT RECEIVED **AT 30 DAYS**, AND ATTEMPTS TO COMMUNICATE HAVE BEEN UNSUCCESSFUL, I CAN DECIDE TO CANCEL MY SERVICES, FORFEITING YOUR DEPOSIT.

CHANGES: **ONCE THE CONTRACT AND DEPOSIT ARE RECEIVED, SERVICES CANNOT BE CHANGED.** IF THERE IS ONE LESS PERSON GETTING MAKEUP DONE THAN WAS ORIGINALLY PLANNED, YOU CAN FIND A REPLACEMENT TO GET MAKEUP OR THE SERVICE IS FORFEITED, THEREFORE NON-REFUNDABLE. FOR TIME AND/OR LOCATION CHANGES, PLEASE NOTE THAT THIS MAY AFFECT HOW MANY MAKEUPS I CAN ACCOMPLISH WITHIN OUR TIMEFRAME. THIS COULD ALSO UNFORTUNATELY LEAD TO A CANCELLING OF MY SERVICES DUE TO A SCHEDULLING CONFLICT. IF THIS OCCURS, ANY PAYMENTS MADE BEYOND THE 30% ARE REFUNDED. SO PLEASE, TRY AND HAVE THE GENERAL OUTLINE OF YOUR DAY PLANNED WHEN BOOKING. HAVING THAT BASIC TIMELINE RIGHT AT THE BEGINNING OF BOOKING WITH ME IS WHAT SECURES OUR ARRANGEMENT.

CANCELLING: AS STATED ABOVE, I CAN CHOSE TO CANCEL MY SERVICES BASED ON A LACK OF COMMUNICATION, LATE PAYMENT, LAST MINUTE SCHEDULE CHANGES THAT DO NOT ALLIGN WITH PREVIOUS ENGAGEMENTS/ CONTRACTS, SEVERE ILLNESS/EMERGENCY, AND POOR TREATMENT/DISRESPECT. IF CANCELLATION IS DUE TO AN ILLNESS OR EMERGENCY, A FULL REFUND WILL BE MADE AND I WILL DO MY BEST TO FIND A REPLACEMENT. IF A REPLACEMENT CANNOT BE FOUND, UNFORTUNATLY, NO ARTIST WILL BE PROVIDED BUT A **FULL REFUND** WILL BE MADE WITHIN 48HRS. IN THE CASE OF ANY TYPE OF VERBAL OR PHYSICAL ABUSE, IT WILL NOT BE TOLERATED. BULLYING AND ANY OTHER TYPE OF DISRESPECTFUL BEHAVIOUR 100% ENDS IN AN IMMEDIATE CANCELLATION AND **WALK OUT, WITH NO REFUND.** SERVICES WILL NOT BE COMPLETED IN A TOXIC, UNCOMFORTABLE ENVIRONMENT. **THIS IS NON-NEGOTIABLE.**

ADDITIONAL ARTISTS: SINCE I AM ONLY ONE PERSON, I CAN ONLY ACCOMPLISH SO MANY MAKEUP LOOKS WITHIN OUR ALLOTTED TIME. I WISH I WAS THE FLASH BUT UNFORTUNATELY, I AM NOT! THIS IS WHY I PUT TIME SLOTS ON ALL MY SERVICE LISTS SO WE CAN COME UP WITH A SCHEDULE. IF THERE ARE MORE SERVICES REQUIRED THAT I AM UNABLE TO COMPLETE, I WILL BOOK A SECOND ARTIST AT NO COST TO YOU. I HAVE A LIST OF MAKEUP ARTISTS IN MY ARSENOL SO DO NOT BE AFRAID TO ASK FOR RECOMMEDATIONS!

HYGIENE GUARANTEE: **ALL TOOLS AND PRODUCTS ARE SANITIZED PRIOR TO USE.** A METAL SPATULA IS USED TO DEPOT OR SCRAPES PRODUCT OFF AND ONTO A SANITIZED PALETTE. LIPGLOSSES/MASCARAS ARE USED WITH DISPOSABLE MAKEUP TOOLS TO PREVENT CONTAMINATION. ANY PENCILS USED ARE CLEANED WITH ALCOHOL AND SHARPENED WITH A SANITIZED SHARPENER. HANDS ARE SANITIZED AND/OR COMPLETELY WASHED BEFORE EACH

SERVICE OR AFTER CONTAMINATION. THE ODDS OF GETTING AN INFECTION FROM MY KIT SHOULD BE IMPOSSIBLE. THAT IS ALSO WHY MY KIT AND PRODUCTS/TOOLS ARE OFF LIMITS TO EVERY OTHER PERSON BUT MYSELF. IF PRODUCTS ARE CONTAMINATED DUE TO THIS, THE **BRIDE IS RESPONSIBLE FOR REPLACING THE CONTAMINATED PRODUCTS** WITH NEW REPLACEMENTS OR AN ETRANSFER IN THE AMOUNT OF THE PRODUCTS COST. MY BRUSHES ARE BATHED IN BABY SHAMPOO AND AIR DRIED AFTER A LONG DAY OF EXCITEMENT AND PACKED AWAY IN MY KIT. IF BRUSHES NEED TO BE CLEANED ON THE JOB, I USE A WELL KNOWN MAKEUP BRUSH SANITIZER/CLEANER, THAT DRIES WITHIN SECONDS. THIS ALLOWS IT TO BE USED AGAIN WITHOUT CAUSING IRRITATION TO THE CLIENT OR CAUSING ANY HYGIENE CONCERNS.

SATISFACTION GUARANTEE: I TAKE PRIDE IN MY WORK AND WILL DO EVERYTHING I CAN TO MAKE YOU FEEL BEAUTIFUL. AFTER EACH SERVICE, I ASK YOU FOR FEEDBACK SO I CAN MAKE CHANGES TO SUIT YOUR VISION. CHANGING A LIP COLOUR, OR ADDING MORE BRONZER WILL NOT BE A CONFRONTATION! SO PLEASE, DO NOT WORRY ABOUT LETTING ME KNOW EXACTLY HOW YOU FEEL. THIS IS ALSO WHY I RECOMMEND A TRIAL. A TRIAL JUST GETS US ON THE SAME PAGE AND ALSO GIVES US SOME TIME TO VIBE! I WILL CHANGE AS MUCH AS I CAN TO MAKE SURE YOU LEAVE MY CHAIR SATISFIED. TELLING ME IF A CHANGE NEEDS TO BE MADE WHILE STILL IN MY CHAIR KEEPS US HAPPY AND ON TRACK FOR THE DAY. ALTHOUGH I DO NOT DO REFUNDS, I DO CARE ABOUT MY REPUTATION AND WILL ALWAYS DO MY BEST. IF MY BEST IS NOT ENOUGH, AT SOME POINT, I WILL HAVE TO MOVE ON TO ANOTHER IN THE SCHEDULE CLIENT.
